4. I have reviewed the photographs listed exhibits 1a, 1b, 1c, 1d, 1e and 1f. These photographs are true and accurate pictures of the interior and exterior of the office and manufacturing facility which FiberView previously rented.
5. The pictures confirm the fact that there are no windows in the manufacturing facility. The manufacturing facility is comprised entirely of concrete block construction with two solid and windowless steel bay doors. It would be impossible for someone from the outside to see inside the manufacturing area both during the time that FiberView was a tenant and at the present.
